Multi-Com Granular Iron 10% is recommended for application to soil<sup>1</sup> to correct iron deficiencies, as determined by petiole and soil testing, in field, vegetable, tree, vine, turf, and ornamental crops. For best results apply in a band with starter fertilizer at seeding time. Broadcast methods and spot applications are also effective. A second application may be applied as a side dressing with rate recommendations from your Certified Crop Advisor (CCA).
