GENERAL RECOMMENDATIONS

Multi-Com Granular Plus 3 is recommended for application to soil¹ to correct Boron, Copper, Magnesium, Manganese, and Zinc deficiencies, as determined by petiole and soil testing, in field, vegetable, tree, vine, turf, and ornamental crops. For best results apply in a band with starter fertilizer at seeding time. Broadcast methods and spot applications are also effective. A second application may be applied as a side dressing with rate recommendations from your Certified Crop Advisor (CCA).

¹DO NOT APPLY this product as a liquid foliar. It is not designed to be dissolved and used as a foliar spray or applied via fertigation.
