Active Ingredient: < 1.0% by wt.

Bradyrhizobium japonicum 2 x 10⁸ CFU/g

Inactive Ingredients: > 99.0% by wt.

DIRECTIONS FOR APPLICATION

- Use N-DURE to inoculate only the legume(s) designated on this package.
- Use before the expiration date marked on the package.
- Label seed with the same expiration date if intended for resale.

SLURRY METHOD APPLICATION

- Dampen the seed with non-chlorinated, clean, cool water at a rate of 8.5 oz. (241 g) of water per 50 lbs. (22.7 kg) of seed.
- Add appropriate amount of inoculant (2.5 oz. (70.8 g) per 50 lbs. (22.7 kg) of seed) and mix water, seed, and inoculant thoroughly until the seed is uniformly coated.
- This method should be done in a container outside the planter box.
- Allow 1-3 minutes for mixture to dry and then plant as soon as possible.
- N-DURE can also be applied directly onto the seed. Mix seed and inoculant thoroughly until seed is uniformly coated. Layering seed and inoculant will aid in this process.
- Applying the inoculant dry is also recommended for seed that is pre-treated with fungicide. However, maximum seed adhesion will not be obtained by applying this product dry.

For soils that have never been host to this specific legume, apply N-DURE at 2.0x the suggested rate OR use N-DURE with a liquid inoculant product from Verdesian Life Sciences, U.S., LLC.

STORAGE/DISPOSAL RECOMMENDATIONS

- Store in a cool, dry place out of direct sunlight.
- Keep from freezing.
- Store between 40°F and 77°F (4.4°C and 25°C).
- Open package only when ready for use.
- Do not allow product or packaging to become wet, or exposed to high humidity.
- Do not store product in an area to be fumigated.
- Small amounts of product which cannot be used according to the label instruction may be disposed of in a landfill.
